n Feb 6th, British fraudster Derick Coles was sentenced to $6^{1}/_{2}$ years, a \$15000 fine and restitution costs of \$4,232,621.30, a forfeiture judgment of \$530,000 and a special assessment of \$200.

His crime? As a failed businessman in the UK he reinvented himself as the owner of New Horizons Group in Sarasota, after other, failed US ventures, and he conned Brits who wanted to migrate using the EB-5 investment Visa. Terry Dunne was one of those who fell victim to the scam in 2007 and created the website derickcoles.com devoted to hunting down Coles and gathering additional evidence against him.

Personally, we saw Coles 'in action' at a migration

gifted (Pine View School). Pine View is state funded, takes grades 2 to 12 and so has an elementary, middle and high school, a total of some 2200 students. The campus is university-style, off Old Venice Road, Osprey. Two of my courses ((a) Multivariable and Vector Calculus (b) Differential Equations) give 200 level credit at University, so enabling the high school students to be on the way to qualification for a degree. I started at Pine View in 2010 and was fortunate to come across a particularly outstanding junior, Anthony Grebe, who we entered for the US national competition "Who Wants to be a Mathematician". Anthony reached the finals, won his semi-final (beamed live across the internet from New Orleans) and came a close runner-up, winning several thousand dollars for himself and for the School, together with other prizes. Later that year w put forward a team of five students in the national "Moody Megamath Challenge". There were some 578 teams across the USA competing, our team getting to the finals in Manhattan and, amazingly, we won. The first prize was \$20,000 and the paper by the team has subsequently been published in a learned journal. The challenge involved addressing the drought issue in western states, modeling Lake Powell and Lake Mead over 3 years (given projected rainfall), the impact on hydro-electric generation there, the impact of the legal rights of neighboring states and Mexico to draw off water, and finally the impact on agriculture in the region.

I have helped Anthony sharpen a math paper he wrote, now submitted to an international journal

and we also have a joint article in progress. Contact with State College of Florida (SCF) led to me being invited to give the annual lecture in Math at SCF; I was again invited this year to give the Fall holiday lecture and involved both Anthony and another student (Anna Beatty) in the presentation, giving them valuable experience of public speaking. I also accepted a position of Visiting Scholar at New College. With the courses and results going well last year, the student numbers doubled and I was also asked to teach Honors Calculus. Further, Anthony had run out of math courses he could take and so special permission was given by the School, SCF and the Sarasota School Board for me to teach a fourth course, a high level university course in Complex Variable theory. Only Anthony and Anna are taking it and, with just two students, I offered to give this on a voluntary basis. So it is a busy year!!

When I began, I thought about the problem of maintaining the concentration and interest of such young students over a 50 minute period and decided to take a 4 minute break two thirds of the way through, doing card tricks, mathematical puzzles and relating experiences of working in industry. commerce, government and academia. The students did a feature article about me in the 2010 yearbook, coining the word "factoids" for the latter.

In the Spring of 2011, Pine View ran an all-day reenactment of the 1776 War of Independence and. being a Brit, I was invited to dress up as George III for the day, taking part in a number of events including debates defending the role of the monarchy. 
