isit to Solomon's Castle on March 14th. The home and studio of internationally known sculptor Howard Solomon. His work is held by collectors and museums nationwide and 240-432-2851 overseas.

The three story castle presents a gleaming silver face to the visitor since it is built with aluminum printing plates thrown out by the local newspaper.

The spacious interior displays an extensive range of Solomon's highly imaginative and often quirky sculptures made from discarded materials such as oil drums, broken appliances, car parts, drink cans plus many other junk items.

A few yards from the castle is the Boat in the Moat, a 60 foot replica of a 16<sup>th</sup> century Portuguese galleon, which serves as the Moat's restaurant.

The lunch menu comprises a wide range of sandwiches, hot meals and salads with prices ranging from \$7.95 to \$10:00.

As a consequence, and with some trepidation, I am delighted to be able to inform my Brit friends that I will be setting out to make this distant dream a reality in late March 2014. There are some daunting statistics about the trail that resonate

with me, quite apart from the astonishing 2185 miles I'll be hiking. I will travel through 14 states, in approximately 6 months, where I may encounter bears, snakes, mountain lions and elk, while the elevation gain along the trail is the equivalent of 16 times up Mt Everest. Happily, there will also be a few downhills as well. I'll be sleeping in a tent, hanging my food (and toothpaste!) from a high



branch to discourage foraging bears, as well as going considerable periods of time without the benefit of a shower. The least said about my impending toilet arrangements the better. Suffice to say, my dear wife has equipped me with a garish orange trowel to dig holes and bury "stuff."

The equipment is costing quite a bit, though keeping weight down is a priority, so it seems that the lighter it is, the more expensive it is. Thus far, I have invested in boots, backpack, trekking poles, tent, sleeping bag, sleeping pad, stove and fuel, water bottle, water purifier (don't ask) and my wife bought me a solar charger that will be attached to my enable me to charge backpack to mv phone.

I realize that, at 61, my window of opportunity to do this thing is closing somewhat rapidly and I'd hate to look back in 10 years and think "if only...." I'm hoping that, instead, I'll be able to look back and say "I'm REALLY glad I did that."

The details are as follows:

Every Friday at 9.30 am from Phillippi Harbor Club, 1780 Phillippi Shores Drive, Sarasota, FL 34231. You can call me on my cell phone, 941-993-9752, to reserve space. I can take 4-5 people at a time. The only requirement is that everyone chips in for fuel (\$5 each).

This is weather permitting, of course; but I will call and let you know if the boat is not going out.

Sun cover. There will be shade on the boat but I recommend bringing a hat and sunglasses. Sun block is also needed.

I will be doing this on a weekly basis and will see how many people take me up on it. If anyone has an interest in fishing, then let me know and we can arrange a fishing trip as well.

### **Nokomis**



f you missed our kayak outing last fall or were one of the lucky few who didn't here's another opportunity to experience our next silent seas adventure. This time our professional guide, John Sarkozy, who has nearly 20 years of experience in running local kayak trips under the auspices of the American Littoral Society http://www.littoralsociety.org/ index.php/trips-a-events/sarasota. will be guiding us along the "Waterways of Nokomis".

We'll undertake a leisurely North to South figure-eight route among the small islands, mangroves and sand bars dotting the ICW along Casey Key. There will be one "wilderness stop" during our three-hour journey of paddling and observation.

**DATE and TIME**: Wednesday, March 26, 2014. Please arrive by **9am** to be prepared for our launching at 9:30.

**DIRECTIONS** to the Launch Site: In Nokomis on Rt 41 turn west onto Albee Rd, proceed 0.9 miles over the ICW bridge, turn right onto Casey Key Rd. and then immediately turn right around a wooden & chain link fence and then over a short bridge and finally turn left continuing along the dirt road approx. 0.1 miles to a break in the mangroves on the left marked by a wooden fence.

John provides all the necessary equipment and safety gear and especially welcomes first time kayakers. As he did for several newbies last year, he'll have you quite comfortable on the water in a matter of minutes. He can accommodate up to 11 paddlers in single kayaks and twosomes in up to three double (tandem) kayaks or 17 guests in total.

Fees are \$25 per person, \$20 if you are a member of ALS or \$5 if you bring your own kayak and life vest. Recommended personal items are: a sun hat, plenty of water, sunscreen, quick-dry clothing and shoes that you don't mind getting wet. John usually has granola bars for the rest stop.

Kayak Outing on the Intracoastal Waterway in Après-kayaking we will adjourn for lunch at a quite nearby, waterfront eatery most likely Pop's Sunset Grille.

#### **An Essex Treasure**

Among the many beautiful country mansions of England, Audley End House ranks as one of the loveliest. Set near Walking with a friend in the dark is better than walking the lovely town of Saffron Walden, Audley End was once a alone in the light." Benedictine monastery seized by Henry VIII and passed on to a court favorite. A great Jacobean mansion was raised by First Earl of Suffolk by the early 17<sup>th</sup> Century, recognized

as the largest house in Britain. This engaged the suspicions of James I who placed the earl and his wife in the Tower for embezzlement from the Treasury and eventually, Audley End became a Crown property and then a royal palace to Charles II.

By the 18<sup>th</sup> Century the property was passed on to Baron Braybrooke and house was reduced to a more manageable size and is substantially the structure and gardens that we can enjoy today. The house is in the grand and monumental style of its day and its interior and collections are truly magnificent. The rooms were redesigned by the Third Baron Braybrooke in 1825 in a lavish Regency style with beautiful furniture and decorations. The art collection contains paintings by Holbein and Canaletto along with beautiful tapestries. The gardens were designed by the famous Capability Brown and are extensive and are arguably one of the best, if not the best, in Britain. It is an estate, parkland and a series of gardens with long avenues of trees, a parterre garden, a rose garden and fountains, and a walled kitchen garden now in use as a working organic kitchen garden.

The property is now in the hands of English Heritage. The Neville family (The Lords Braybrooke) suffered, as many did during World War II. Henry Neville, the 7<sup>th</sup> Lord Braybrooke died in March 1941 and then came the imposition of substantial death duties upon their fortunes. Tragedy struck again when a younger son, George Neville, was killed in August 1941 when his corvette, HMS Picotee was sunk in the North Atlantic by a U-boat. The eldest son, Richard Neville, the 8th Lord Braybrooke, served in the Grenadier Guards and was killed in action in North Africa in 1943, which occasioned another round of death duties on the family which their fortune could not survive. As part of the tax settlement, Audley End House was sold to the Ministry of Works, but the current Lord Braybrooke and his family retain the right to reside on the property. Audley End House is easily accessible from London by British Rail as Audley End Station is nearby.






Countries in blue drive on the left.
